Expression of Interest (EOI) for installation of oil and grease traps for treating domestic and minor industries waste water in Shillong, Meghalaya.

Government of Meghalaya in the Urban Affairs Dept is undertaking a comprehensive programme for management of domestic waste water and effluents from minor and small industries like workshops, garages etc in all towns in the State of Meghalaya. The programme includes installation of common 'oil and grease traps' for a group of households or workshops for preliminary treatment.

The Director of Urban Affairs, hereby invites **Expression of Interest (EOI)** from interested agencies for design, supply, installation and commissioning of oil and grease traps with capacities ranging from 5-10 KLD and other necessary works for the city of Shillong and other towns in the State, namely, Tura, Nongstoin, Jowai, Nongpoh, Williamnagar, Baghmara, Resubelpara, Ampati, Khliehriat, Mawkyrwat.

Interested firms will be required to provide the following information along with the relevant literature within 4th September, 2017:

- i. Background of the firm; regional presence and experience should also be clearly indicated.
- ii. Description of the Technology available with them including process description, equipment details, unit details, power requirements, chemicals and other consumables required, manpower required to operate the plant and land area required;
- iii. Indicate time required for supply and installation of the oil and grease traps of a suitable sizes
- iv. Mode of execution including operation & Maintenance by Annual Maintenance Contract, PPP model, Build-Own, Operate and Transfer (BOOT), Build-Own & Operate (BOO), Sharing of the investments etc.;
- v. General and overall experience of the firm, staffing and key financial information;
- vi. Similar projects undertaken in India/abroad during last 5 years, along with the credentials from the client.

This Expression of Interest (EOI) should be delivered at the office of the undersigned on or before 3.00 PM of 04.09.2017 and the same will be opened on the same day at 3.30 PM in the presence of the proposers or their authorized representatives.
